

Reconnect with Curtin Competition – Terms and Conditions

1. Instructions on how to enter and other details contained within promotional advertisements for this competition form part of the conditions of entry.
2. Entry into the competition signifies acceptance of all conditions. Entrants are required to abide by the Terms and Conditions as presented.
3. The Terms and Conditions of this competition are governed by the laws of the State of Western Australia.
4. The competition is being run by Curtin University, GPO Box U1987, Perth, Western Australia, 6845 (“Curtin”).
5. The Reconnect with Curtin Competition commences at 9am Australian Western Standard Time (AWST) on Wednesday 22 November 2017.
6. The closing time for entering the competition is 9am AWST on Wednesday 13 December 2017.
7. Entry to the competition is limited to Alumni (graduates) of the WA Institute of Technology (WAIT) and Curtin University.
8. To enter the competition, the entrant must:
 - (a) Update their details online at <https://alumni.curtin.edu.au/responsive/get-involved/reconnect-with-curtin>
 - (b) Details entered in the form must be true and correct at the time of submission. Any entrant found to update fake or incorrect details will be disqualified from the competition.
9. Entry to the competition is free. Entrants will be responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
10. Entrants may only enter the competition once.
11. There will be a total of three (3) prizes. These prize will be:
 - a) 1st Prize: 360fly 360° 4K Camera (1 available)
 - b) 2nd Prize: Apple Watch Series 2 (1 available)
 - c) 3rd Prize: BOSE QuietComfort 35 Over-Ear Wireless Headphones (1 available)
12. There will be one (1) draw at 12pm on Wednesday 13 December 2017 at Curtin University, Bentley Campus. The draw will be by random number generator from all eligible entries. Each entry is assigned a unique and sequential identifying number. Using only the RANDOM.ORG Random Integer Generator three (3) names will be returned as the prize winners (1st to 3rd prize respectively).
13. The prize winner will be contacted within seven (7) days of the draw by the contact details supplied by the entrant.
14. If the prize winner does not respond to claim the prize within twenty-one (21) days of the draw, a re-draw will be conducted within thirty (30) days of the original draw date, in the same location, and with the same method. Redraws will continue in the same manner until all prizes have been claimed by prize winners.
15. If the prize winner is under the age of 18 years, the prize will be awarded to the winner’s parent or legal guardian.
16. The prizes can be collected in person by the prize winner, or couriered at no cost to the winner.

If a prize winner who has been contacted and been made aware of their prize winning, and has agreed to collect the prize or for which collection is the only method for receiving the prize, does not collect the prize within thirty (30) days of this contact, a re-draw will be conducted within thirty (30) days of the original draw date, in the same location, and with the same method.
