

## Stay in Touch Competition - Terms and Conditions

1. Instructions on how to enter and other details contained within promotional advertisements for this Competition form part of the conditions of entry.
2. Entry into the Competition signifies acceptance of all conditions. Entrants are required to abide by the Terms and Conditions as presented.
3. The Terms and Conditions of this Competition are governed by the laws of the State of Western Australia.
4. The Competition is being run by Curtin University, GPO Box U1987, Perth, Western Australia, 6845 ("Curtin").
5. The Stay in Touch Competition ("the Competition") commences at 8am Australian Western Standard Time (AWST) on Wednesday 31 January 2018.
6. The closing time and date for entering the Competition is 5pm AWST on Friday 29 June 2018.
7. Entry to the Competition is limited to Curtin alumni (graduates) who have had their degree conferred between October 2017 and June 2018 (inclusive), regardless of whether or not the entrant has completed a previous Curtin degree. The conferral date can be found on Curtin's Award Verification website via [graduations.curtin.edu.au/verification](http://graduations.curtin.edu.au/verification) or on the entrant's graduation certificate.
8. To enter the Competition, the entrant must:
  - a) Update their details online via [curtin.edu/stay-in-touch](http://curtin.edu/stay-in-touch) by 5pm AWST Friday 29 June 2018.
  - b) Include their Curtin award number when updating their details via [curtin.edu/stay-in-touch](http://curtin.edu/stay-in-touch) (for verification purposes). Award numbers can be found on Curtin's Award Verification website via [graduations.curtin.edu.au/verification](http://graduations.curtin.edu.au/verification) or on the entrant's graduation certificate.
  - c) Updated details must be true and correct at the time of submission. An entrant found to update fake or incorrect details will be disqualified from the Competition.
  - d) Updated details can include one or more of the following in a single transaction: name change, email address, postal address, mobile number, home number, employment details (sector, company name, position title or business phone number) or interests (which can be selected from a list in the update details form via [curtin.edu/stay-in-touch](http://curtin.edu/stay-in-touch)).
9. Entry to the Competition is free. Entrants will be responsible for all costs associated with entering the Competition, which may include costs associated with accessing the internet.
10. Entrants may only enter the competition once.
11. Staff employed by Curtin who also graduated at the completion of Semester two (2) of 2017 are eligible to enter the Competition.
12. There will be a total of eight (8) prizes. These prizes will be:
  - a) 1st prize: \$1000 Flight Centre voucher (1 available)
  - b) 2nd prize: \$100 Curtin Co-op voucher (2 available)
  - c) 3rd prize: Two-year Alumni Library Membership valued at \$20 (5 available)
13. There will be one (1) draw at 12pm Australian Western Standard Time on Monday 2 July 2018 at Curtin University, Bentley Campus. The draw will be by random number generator. Each entry is assigned a unique and sequential identifying number. Using only the RANDOM.ORG Random Integer Generator, eight (8) numbers will be returned as the prize winners (1<sup>st</sup> prize through to 3rd prize respectively).

14. The prize winner will be contacted within seven (7) days of the draw by the phone number and email address supplied by the entrant on the update details form via [curtin.edu/stay-in-touch](http://curtin.edu/stay-in-touch).
15. If the prize winner does not respond to claim the prize within fourteen (14) days of the draw, a re-draw will be conducted within twenty one (21) days of the original draw date, in the same location, and through the same method. Redraws will continue in the same manner until all prizes have been claimed by the prize winners.
16. If the prize winner is under the age of 18 years, the prize will be awarded to the winner's parent or legal guardian.
17. The prizes can be collected in person by the prize winner, or emailed or couriered at no cost to the winner.

If a prize winner who has been contacted and been made aware of their prize winning has agreed to collect a prize in person, does not collect the prize within fourteen (14) days of this contact, a re-draw will be conducted within thirty (30) days of the original draw date, in the same location, and with the same method.
