## **Stay in Touch Competition - Terms and Conditions**

- 1. Instructions on how to enter and other details contained within promotional advertisements for this Competition form part of the conditions of entry.
- 2. Entry into the Competition signifies acceptance of all conditions. Entrants are required to abide by the Terms and Conditions as presented.

- 7.   - b) Include their Curtin award number when updating their details via <u>curtin.edu/stay-in-touch</u> (for verification purposes). Award numbers can be found on Curtin's Award Verification website via graduations.curtin.edu.au/verification or on the entrant's graduation certificate.
  - c) Updated details must be true and correct at the time of submission. An entrant found to update fake or incorrect details will be disqualified from the Competition.
